Purpose	<p>Designed to provide all technical and non-technical skills needed to attain a Commercial Pilot Licence with the Civil Aviation Safety Authority (CASA).</p> <p>The course reflects the roles of flight crew personnel performing normal and emergency commercial pilot duties in support of commercial or Defence aviation flight operations.</p> <p>Occupations include:</p> <ul style="list-style-type: none"> Commercial aeroplane pilot Military aeroplane pilot 	
Entry Requirements	<p>Candidates must:</p> <ul style="list-style-type: none"> Successfully complete pre-course assessment (including interview and aptitude testing) Hold a current CASA Class 1 Medical and Aviation Security ID Card (ASIC) VET Student Loan applicants must meet additional entry/eligibility. 	
Study Modes	<p>This course is aligned with the CASR Part 142 Integrated flight training requirements [FULL-TIME].</p> <p>This qualification is an on-campus program combining face-to-face instructor-led theory classes, textbook and self-study learning and individual one-on-one practical sessions.</p> <p>This qualification is conducted via a minimum of 20 hours face to face lessons per week with an additional unsupervised minimum self-study commitment of 5 hours per week.</p> <p>General training hours are between 7.50am to 4:30pm, however these times are subject to change dependent on available flight lessons.</p>	
Course Outcomes	<p>To be awarded the AVI50219 Diploma in Aviation Commercial Pilot Licence - Aeroplane, competency must be demonstrated in a total of 29 units of competency comprising:</p> <ul style="list-style-type: none"> 28 core units, plus 1 elective unit (<i>NOTE – elective units are subject to change</i>). <p>CASA outcomes (issued by third party):</p> <ul style="list-style-type: none"> English Language Proficiency Private Pilot’s Licence - Aeroplane Commercial Pilot’s Licence - Aeroplane Design Feature Endorsement - Manual Propeller Pitch Control (MPPC)

Recognition of Prior Learning	<p>Recognition of Prior Learning (RPL) is offered to applicants at time of enrolment. RPL may include holders of a CASA Recreational Pilots Licence, CASA Private Pilot's Licence and/or a foreign pilot's licence or those that have previous studies, qualifications, and experience.</p> <p>NOTE - this course is aligned with the CASR Part 142 Integrated flight training requirements which requires completion of the full training program (including 150 hours aeronautical experience). Any recognition of prior learning applied may require a change in enrolment to the CASR Part 141 non-integrated flight training program (200 hours aeronautical experience).</p>
